GENERAL CONDITIONS FOR PARTICIPATION

Article I

Organizer of the event

CSOK, Chamber of Commerce, Na Pankráci 14, 140 00 Prague 4, Czech Republic

Article II - Registration forms and distribution of exhibition areas

1. The Registration form for exhibitors in the scope of page number 1 and 2 is mandatory. CSOK decides about acceptance of the registration / application, reduction or expansion of ordered exhibition area. CSOK is not obliged to satisfy possible exhibitor's requirement regarding the allocation of his exhibition.
2. After receiving correctly fulfilled Registration Form for participation, CSOK will send to the exhibitor written receipt. CSOK will send to the exhibitor written confirmation about assignment of exhibition area, allocation and dimension of exhibition area. The allocated exhibition area will be accessible for exposition installation in dates stated in Organizational Directions CSOK. Payment of the whole amount of rent on time is basic condition for exhibitor to obtain the agreed area.

Article III - Rent of exhibition area

1. The rent of exhibition area is always stated in Registration Form or letter sent by CSOK. Every initiated square meter is charged as whole square meter. The smallest possible area is 6 m² in sheltered hall and 15 m² on outside stand.
2. If the exhibitor cancels his participation on the exhibition after signing the Registration Form, he is obliged to pay penalty in the amount of 50 % of the agreed rent. If the exhibitor cancels his participation on the exhibition after receiving the written confirmation from CSOK about allocation of exhibition area, he is obliged to pay penalty in the amount of 100 % of the agreed rent. Paying the penalty abolishes obligations of both parties. Cancellation of participation must be in a written form.

Article IV - Price and payment conditions

1. CSOK will send you a confirmation about receiving the Registration Form and at the same time CSOK will send to the exhibitor advance invoice for rent in the amount of 100 % of the total rent (including VAT if it is the case). Tax certificate will be send according to valid legal regulations.
2. In case of non-payment of the invoice on quoted time, CSOK has the right to withdraw from the contract and the exhibitor is obliged to pay the penalty in the amount corresponding to the invoice amount. Paying the penalty abolishes obligations of both parties.

Article V - Building-up and installation of exhibitions, assembly of exhibits

1. CSOK determines the dates of exhibitions assembling and disassembling and working time.
2. Exhibitor is responsible for all goods rented from CSOK and is obliged to return them once the event is over.

3. The exhibitor is obliged to cover all damages of exhibition area or rented goods.
4. The exhibitor is not allowed to disassemble the exposition before the end of the event.

Article VI - Promotion, advertising and catalog

1. The exhibitor is allowed to promote his products only within his own exposition.

Article VII - Insurance

1. CSOK is not responsible to the exhibitor for any loss, damage or destruction of exhibits and equipment of his stand, goods and other material, no matter if the damage or loss happened before, during or after the whole event organized by CSOK. The exhibitor might contract insurance for those cases.

Article VIII - Final disposition

1. In case that CSOK is not able to open the exhibition, in consequence of by it uncaused circumstances, it is obliged to inform the exhibitor immediately about that fact. All the obligations of CSOK are cancelled. In that case the exhibitor can't claim any right to cover his damages.
